AMENDMENT TO THE TAMIL NADU MOTOR VEHICLES RULES, 1989.

[G.O. Ms. No. 301, Home (Tr-VI), 10th April 2012.]

No. SRO A-12(a)/2012.

In exercise of the powers conferred by Sections 65 and 211 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the draft of the same having been previously published, as required by sub-section (1) of Section 212 of the said Act.

AMENDMENT.

In the said Rules, in rule 132, in the Table, for the entries in columns (2), (3) and (4), against the Serial number 1 in, column (1), the following entries shall, respectively, be substituted, namely:—

(G.O.Ms.No.651 Home Prohibitions & Excise (Transport - VI) dated 02.05/2007)

- a) The application for allotment of Advance / Fancy number should be made in the prescribed format.
- b) The application should be signed by the respective Vehicle Owner.
- c) Allotment shall be subject to the availability of the numbers sought for and at the discretion of the Government. Allotment cannot be claimed as a matter of right.
- d) The advance / Fancy numbers will be allotted only within the jurisdiction of the concerned Regional Transport Officer in which the vehicle owner resides or the place of business if it is a vehicle belonging to institution / firm.
- e) The application for allotment of advance / fancy number to government should be made only after purchase of vehicle.
- f) The application must be accompanied by Xerox copy of the invoice for the purchase of vehicle.
- g) No extension of time limit shall be entertained.
- h) To be availed within 2 month time.
