ORDER:-

The Principal Secretary/ Commissioner of Revenue Administration has sent a proposal for giving in-principle approval of Rs.16.50 lakh for producing a documentary film on tsunami relief and rehabilitation works implemented with the assistance of Asian Development Bank and also to accord sanction of Rs.1,15,576/- for payment to M/s. Accord Advertisement Agencies towards calling of Express of Interest in English National Daily "The Hindu" on 12.11.2008.

2. The Officer on Special Duty (Relief and Rehabilitation) has placed the above proposal before the Empowered Committee meeting held on 23.3.2009. The Empowered Committee has approved the sanction of advertisement charges and advised the Project Management Unit not to proceed with the documentation works further.

3. The Government after careful consideration, accept the proposal of the Principal Secretary/ Commissioner of Revenue Administration as approved by the Empowered Committee and accord sanction for a sum of **Rs.1,15,576/- (Rupees One lakh fifteen thousand five hundred**

and seventy six only) towards the advertisement charges to M/s. Accord Advertisement Agency for calling the Express of Interest in the English National Daily "The Hindu" on 12.11.2008 from "Capacity Building and Implementation Support" component of Asian Development Bank. The Government also direct the Project Management Unit not to proceed with the documentation works further.

4. The expenditure sanctioned in paragraph 3 above shall be debited to the following head of account:-

5. Necessary funds will be provided in the RE/FMA 2009-2010. Pending provision of funds, the Principal Secretary/ Commissioner of Revenue Administration is authorised to draw and disburse the expenditure sanctioned in paragraph 3 above to M/s. Accord Advertisement Agency as per the existing procedure and to send the statement of expenditure, the utilisation certificate and the progress reports as laid down by the World Bank in consultation with the Project Director (ETRP/TEAP) to the Government/ the Accountant General.
