### **ORDER:-**

The Principal Secretary/ Commissioner of Revenue Administration has sent a proposal for sanctioning a sum of Rs.1,44,470/- including service tax towards the cost of advertisement charges for publishing the Express of Interest for Project Management Consultancy for Project Management Unit under Emergency Tsunami Reconstruction Project (ETRP) to the advertiser M/s. He has also requested to include this item of expenditure while sending the proposal for RE/FMA 2009-2010 without fail.
