ORDER:-

In the G.O. first read above, the Government have accorded sanction for the further continuance of the posts of one Project Manager, 2 Project Coordinators, 25 Project Animators and 1 Data Entry Operator for the completion of Livelihood Support Programme under TEAP in Tamil Nadu Slum Clearance Board from 1.11.2008 to 31.1.2009 and also ratified the action of Managing Director, Tamil Nadu Slum Clearance Board in having continued the above mentioned staff from 1.11.2008 to 31.1.2009.

2. The Managing Director, Tamil Nadu Slum Clearance Board has sent a proposal for extending the tenure of the Administration Staff under TEAP viz. 1 post of Project Manager, 1 post of Data Entry Operator and 2 posts of Project Coordinators from 1.2.2009 to 31.3.2009 to complete the spill over work of Livelihood Support Programme at a cost of Rs.63,000/- and to ratify the action of Managing Director, Tamil Nadu Slum Clearance Board in continuing the above posts.

3. The Officer on Special Duty (Relief and Rehabilitation) has placed the above proposal before the Sub-Committee meeting held on 9.4.09. The Sub-Committee has ratified the action of the Managing Director, Tamil Nadu Slum Clearance Board.

The Government after careful consideration, accept the proposal of the Managing Director, Tamil Nadu Slum Clearance Board as recommended by the Sub-Committee and accord sanction for the further continuance of the posts of one Project Manager, two Project Coordinators, and one Data Entry Operator for the completion of Livelihood Support Programme under Tsunami Emergency Assistance Project (TEAP) in Tamil Nadu Slum Clearance Board from 1.2.2009 to 31.3.2009 at a cost of Rs.63,000/- (Rupees Sixty three thousand only). The Government also ratify the action of Managing Director, Tamil Nadu Slum Clearance Board in having continued the above mentioned staff from 1.2.2009 to 31.3.2009.

5. The expenditure involved in the continuance of staff shall be met from the fund already sanctioned towards the Project Management Component.
