### **ORDER:-**

The Project Director, Tsunami Project Implementation Unit, Rural Development and Panchayat Raj Department has stated that all the works under Tsunami Emergency Assistance Project (TEAP) have been completed except Bio-metric system in Nagapattinam District and Craft Village works in Villupuram District which are nearing completion. Self Help Group marketing Complex work at Chennai is under progress. For this purpose, the Project Director, Tsunami Project Implementation Unit, Rural Development and Panchayat Raj Department has sent a proposal for continuance of the one post of Accounts Officer and one post of Block Development Officer/ Superintendent under Tsunami Emergency Assistance Project for Tsunami Project Implementation Unit, Chennai for a further period of 7 months from 1.4.09 to 31.10.2009 at a cost of Rs.2,24,000/-.

3. The Officer on Special Duty (Relief and Rehabilitation) has placed the above proposal before the Sub-Committee meeting held on 9.4.09. The Sub-Committee has approved the proposal.

4. The Government after careful consideration, accept the proposal of the Project Director, Tsunami Project Implementation Unit, Rural Development and Panchayat Raj Department as approved by the Sub-Committee and accord further continuance given to one post of Accounts Officer and one post of Block Development Officer/ Superintendent under Tsunami Emergency Assistance Project for Tsunami Project Implementation Unit, Chennai for a further period of 7 months from 1.4.09 to 31.10.2009 at a cost of **Rs.2,24,000/- (Rupees Two lakhs and twenty four thousand only)** from the funds already available under TEAP.

5. The salary and other expenditure shall be disbursed by the Project Director, Tsunami Project Implementation Unit, Chennai to the above staff. The Project Director is permitted to adopt modes of recruitment/ deputation in consultation with Principal Secretary, Rural Development and Panchayat Raj Department as per the relevant G.O.s read above.

6. The expenditure sanctioned in paragraph 4 above shall be debited to the following head of account:-
