#### **ORDER:-**

The Chief Executive Officer, Tamil Nadu Maritime Board has sent a proposal to accord necessary ratification for further continuance of the 10 additional posts for the period from 1.5.2008 to 30.9.2008 and necessary permission to continue 3 additional posts from 1.10.2008 to 30.6.2009 and also to accord sanction for an amount of Rs.23,81,000/- towards staff salary from 1.12.2007 to 30.6.2009.

3. The Officer on Special Duty (Relief and Rehabilitation) has placed the above proposal before the Sub Committee held on 9.4.2009. The Sub Committee has approved the proposal.

4. The Government after careful consideration accept the proposal of the Chief Executive Officer, Tamil Nadu Maritime Board as approved by the Sub-Committee and accord ratify for the further continuance of 10 additional posts for the period from 1.5.2008 till 30.9.2008 and permit to continue 3 additional posts from 1.10.2008 to 30.6.2009. The Government also accord sanction for a sum of **Rs.23,81,000/- (Rupees Twenty three lakh eighty one thousand only)** towards staff salary from 1.12.2007 to 30.6.2009.

5. The expenditure sanctioned in paragraph 4 above shall be debited to the following head of account:-

6. Necessary funds will be provided in RE/FMA 2009-10 to meet the expenditure sanctioned in paragraph 4 above. Pending provision of funds in RE /FMA 2009-10, the Section Officer (Bills), Highways Department is authorized to draw and disburse the amount sanctioned in paragraph 4 above as per the existing procedure to the Chief Executive Officer, Tamil Nadu Maritime Board by means of necessary adjustment bills for adjusting into the Personal Deposit Account of Tamil Nadu Maritime

Board. The sanctioned amount shall not be paid in cash but contra credited into the following head of account :-
