ORDER:

In the Government Order first read above, the Government have accorded sanction an amount of Rs.2234.00 lakhs towards repair, reconstruction and upgradation of Government Hospital, Primary Health Centre and Health Sub-Centres.

2. In the Government Order second read above, among others, the Government have accorded revised administrative sanction for Rs.1,49,01,000/- for the works of construction of OP-Block and ICCU in Government Hospital in Pudukottai District and construction of OP-Block in Government Hospital at Gandarvakottai in Pudukottai District.

3. The Chief Engineer (Buildings), Public Works Department has stated that Rs.44,67,000/- is required during 2009-2010 for the works of construction of OP-Block and ICCU in Government Hospital in Pudukottai and construction of OP-Block in Government Hospital in Gandarvakottai in Pudukottai District and has requested to provide the balance of Rs.34,99,000/- (Rs.44,67,000/- minus Rs.9,68,000/-) in the RE/FMA 2009-2010 and necessary orders to incur the expenditure for Rs.34,99,000/- pending provision of funds in the RE/FMA 2009-2010 over and above the budget provisions.

4. The Government accept the request of the Chief Engineer (Buildings), Public Works Department and accord sanction for a sum of **Rs.44,67,000/- (Rupees Forty four lakhs and sixty seven thousand only)** for the works of construction of OP-Block in ICCU in Government Hospital in Pudukottai District and construction of OP-Block in Government Hospital at Gandarvakottai in Pudukottai District during 2009-2010.

5. The expenditure sanctioned paragraph 4 above shall be debited to the following head of account:-

4210 Capital Outlay on Medical and Public Health - 01 Urban Health Services - 110 Hospital and Dispensaries (including Pharmacy) - II. State Plan-QA. Works under Emergency Tsunami Reconstruction Project (ETRP) with assistance from World Bank - Public Works Department (Buildings) - 16 Major Works (DPC 4210-01-110-QA-1605)

6. Necessary funds will be provided in RE/FMA 2009-2010. Pending provision of funds, the Chief Engineer (Buildings), Public Works Department, Chennai is authorized to draw and disburse the amount sanctioned in paragraph 4 above as per the existing procedure and send the statement of expenditure, utilization certificate and the progress reports as laid down by World Bank in consultation with the Project Director (Emergency Tsunami Reconstruction Project (ETRP) and Tsunami Emergency Assistance Project (TEAP)) to the Government and the Accountant General.

7. The Chief Engineer (Buildings) is requested to include this amount while sending the budget proposal for RE/FMA 2009-2010 without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.38822/Health-II/09-1, Dated:20.7.09 and ASL No.404 (Four Hundred and Four).
