ORDER:-

In the G.O. first read above, the Government have accorded sanction for a sum of Rs.42,000/- (Rupees Forty two thousand only) towards rent for Nagapattinam sub-division office of Tamil Nadu Slum Clearance Board for one year from 1.10.2007 to 30.9.2008 at the rate of Rs.3,500/- per month.

2. The Managing Director, Tamil Nadu Slum Clearance Board has informed that the private building located at Door. No.3, Paul Daniel Street, Nagercoil in Kanniyakumari District was chosen for the accommodation of the office building since no suitable public/Government buildings are available in Nagercoil for the sub-division office. He has further informed that the Executive Engineer, Tirunelveli Division, Tamil Nadu Slum Clearance Board, rent for the office building was fixed as per Public Works Department schedule of rates for the year 2008-09 at Rs.5058/- per month and the owner of the private building has also accepted to let out the building at the rent of Rs.3,500/- per month.

3. The Managing Director, Tamil Nadu Slum Clearance Board has sent a proposal for sanction of rent of Rs.3,500/- per month for a period of one year from 1.8.2008 to 31.7.2009 under Emergency Tsunami Reconstruction Project (ETRP) for accommodating the Sub-Division Office, Nagercoil in Kanniyakumari District in a private building.

4. The Officer on Special Duty (Relief and Rehabilitation) has placed the same before the Sub-Committee meeting held on 8.5.2008. The Sub-Committee has approved the proposal.

5. The Government accept the recommendation of the Sub-Committee and accord sanction for a sum of **Rs.42,000/- (Rupees Forty two thousand only)** towards rent for Nagercoil in Kanniyakumari District sub-division office of Tamil Nadu Slum Clearance Board for one year from 1.08.2008 to 31.07.2009 at the rate of Rs.3,500/- per month under Emergency Tsunami Reconstruction Project (ETRP).

6. The expenditure sanctioned in paragraph 5 above shall be debited to the following head of account:-

7. The amount sanctioned in paragraph 5 above shall not be paid in cash but credited to the following head of account:-

The Director of Treasuries and Accounts, Chennai, is authorized to draw the amount sanctioned in paragraph 5 above by means of an account Payee Cheque in favour of Personal Deposit account of Tamil Nadu Slum Clearance Board by indicating the Account number thereon and disburse the same to the Tamil Nadu Slum Clearance Board.

9. The Managing Director, Tamil Nadu Slum Clearance Board is requested to send the Statement of Expenditure, Utilization Certificate and the Progress reports in consultation with the Project Director (ETRP/ TEAP) to the Government/ Accountant General.
