#### **ORDER:-**

In the G.O. first read above, the Government have accorded administrative sanction to Evaluation and Applied Research Department to take up the study on livelihood assistance provided to the Self Help Groups in the tsunami affected areas in Tamil Nadu and a sum of Rs.4 lakhs was sanctioned towards cost of study.

2. In the G.O. second read above, the Government have accorded sanction for a sum of Rs.2,00,000/- (Rupees Two lakhs only) towards the evaluation study on "Relief and Rehabilitation measures by providing assistance to Self Help Groups in Tsunami affected areas".

3. In the letter third read above, the Officer on Special Duty (Relief & Rehabilitation) has stated that the amount of Rs.2.00 lakhs sanctioned in the G.O. second read above could not be drawn resulting in surrender into Government account and the G.O. could not be acted upon. As the department has completed the study and sent the final report, the balance amount of Rs.2.00 lakhs has to be drawn and paid to the department concerned. He has, therefore, requested to issue orders for revalidating the above G.O. to draw and disburse the balance amount of Rs.2 lakh to the department under appropriate head of account shown in the above said G.O. by providing funds in RE/FMA 2009-2010 with ASL No.

The Government have examined the request of the Officer on Special Duty (Relief & Rehabilitation) and hereby revalidates the G.O. in the reference second read above and accord sanction for a sum of **Rs.2,00,000/- (Rupees Two lakhs only)** towards evaluation study on Relief and Rehabilitation measures by providing assistance to Self Help Groups in Tsunami affected areas.

He is also requested to include the above expenditure, while sending proposal for RE/FMA 2009-2010 without fail.

The Pay and Accounts Officer (East), Chennai-5 is requested to honour and admit the bill presented by the Principal Secretary/ Commissioner of Revenue Administration towards the evaluation study on Relief and Rehabilitation measures by providing assistance to Self Help Groups in Tsunami affected areas pending provision of funds in RE/FMA 2009-2010.
