ORDER:

The Project Management Unit of Emergency Tsunami Reconstruction Project (ETRP) has sent a proposal for purchase of a Toyota Innova VXBQ (Diesel driven) vehicle on Government rate at Rs.10,97,119/- under "Implementation Support" of Emergency Tsunami Reconstruction Project (ETRP).

2. The Officer on Special Duty (Relief & Rehabilitation) has placed the above proposal before the Sub-Committee at its meeting held on 11/9/2009. The Sub-Committee observed that the existing vehicle used by Officer on Special Duty (Relief & Rehabilitation) for inspection is not in a road worthy condition for undertaking long distance trips for the purpose of inspecting the project works, that the Externally Aided Projects require monitoring and inspection by the Officer on Special Duty (Relief & Rehabilitation) to get the project completed within the specified time line and that therefore the Officer on Special Duty (Relief & Rehabilitation) may be permitted to purchase a car as per the existing Government guidelines for purchase of vehicles for Head of Departments for the purpose of inspection of Tsunami affected areas to the extent possible.

3. The Principal Secretary/ Commissioner of Revenue Administration has requested to permit the Officer on Special Duty (Relief & Rehabilitation) to purchase TATA Indigo Petrol GLX/AC Car as per guidelines issued in paragraph 5 of G.O.Ms.No.1229, Home (TR.IV) Department, Dated: 21.12.2006.

4. The Government after careful consideration, accept the request of the Principal Secretary/ Commissioner of Revenue Administration as approved by the Sub-Committee and accord sanction for a sum of **Rs.5,05,000/- (Rupees Five lakh and five thousand only)** inclusive of 10% Escalation towards the purchase of a new TATA Indigo Petrol GLX/AC Car for the use of Officer-on-Special Duty (Relief and Rehabilitation), Revenue Administration Department.

5. The expenditure sanctioned in paragraph 4 above shall be debited to the following head of account:-

6. Necessary additional provision of Rs.5,05,000/- will be made in the RE/FMA 2009-2010. Pending provision of funds in RE/FMA 2009-2010, the Principal Secretary/Commissioner of Revenue Administration is authorized to draw and disburse the amount sanctioned in paragraph 4 above as per the existing procedure. He is also requested to include this expenditure while sending proposal for RE/FMA 2009-2010 to Government in Finance Department.

7. The Pay and Accounts Officer (East), Chennai-600 005 is requested to admit and honour the bill, pending provision of funds in RE/FMA 2009-2010, if the bill is otherwise in order.
